Submission of Application

1. The application forms can be downloaded from the school website (<https://www.mcs.edu.hk/form-one-admission>).
2. The completed application form must be submitted to our school in person with the supporting documents **between 8:00 a.m. and 3:00 p.m. on 8 July 2025 (Tuesday)**. No application will be accepted before or after the specified period.
3. When you submit your application in person to our school, arrange the required documents in an **A4 transparent plastic folder** in the following order:

	For applicants previously applied for Form One Discretionary Places (DP):	For <u>NEW</u> applicants:
<i>Item #1</i>	The completed “Application Form for Form 1 Extra Places (DP Applicant)”	The completed “Application Form for Forms 1-4 Extra Places”
<i>Item #2</i>	Copy of the annual/year-end academic report of Primary 6 and any other updated/relevant documents	Copies of the annual academic reports of Primary 4, Primary 5, and Primary 6

4. A non-refundable application fee of **HK\$75** is required for each application. Please pay **in cash** and **in exact amount**. No change will be provided.
5. Please bring along the **original** of the applicant’s Birth Certificate/Identity Card or other documents of Identity (for verification purpose only).
6. Copies of awards or certificates or courses attended and/or recommendation letters issued by the applicant’s primary school will NOT be accepted with this application.
7. Please ensure that you have completed all the required information and documents. In case of any omission, your application will not be processed.

Entrance Examination and Interview Arrangements

1. Applicants will be invited to attend an entrance examination **in the afternoon (2:00-4:00 p.m.) on 9 July 2025 (Wednesday)**.
2. Parents of selected applicants will be notified of the interview arrangements **on 10 July 2025 (Thursday) by phone**.

Important Reminders

1. All applicants are reminded to complete the registration procedures with the secondary school to which they have been allocated.
2. Your application should be deemed unsuccessful if you do not receive any notification by the end of August.
